Overview

- PAS stands for Presidentially Appointed with Senate Confirmation. Per the Morris K. Udall and Stewart L. Udall Foundation's (Udall Foundation) enabling legislation, there are a total of nine (9) PAS Trustee positions on the agency's Board of Trustees.
 - The start date for a PAS Trustee is the Presidential Appointment Date if known. If the Presidential Appointment Date is unknown, the Senate Confirmation Date is used as the start date.
 - PAS Trustees may serve in carryover status after their term expires and serve until they are reappointed, replaced, or resign.
- Per the Udall Foundation's enabling legislation, there are also four (4) Trustees that serve on the agency's Board of Trustees because of their office (ex officio positions): the Secretaries of the Interior and Education (or their designees), the President of the University of Arizona, and the chairperson of the President's Council on Environmental Quality (CEQ).
 - The start date for the Secretaries of the Interior and Education and the CEQ chairperson on the Udall Foundation Board is the Presidential Appointment Date if known. If the Presidential Appointment Date is unknown, the Senate Confirmation Date or swearing in date (if known) is used as the start date. (There are two exceptions to the above shown in this history. Since Richard W. Riley and Bruce Babbitt were appointed as Secretaries in 1993 before the Udall Foundation Board of Trustees commenced operations in 1994, their entries show a start date of 1994.)
